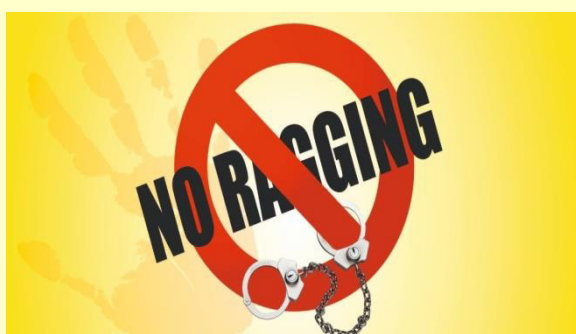

### **RAGGING IS A CRIME AND PUNISHNABLE OFFENCE**

**(In Cognizance of UGC Regulations, 2009)**

**Krishnagar Government College, affiliated to Kalyani University is committed to ZERO TOLERANCE POLICY ON ANY FORM OF RAGGING WITHIN OR/AND OUTSIDE THE CAMPUS.**

**Ragging, in any form or by any means, is banned in the college and anyone found guilty of engaging in or abetting such acts is liable to be punished.**

**Ragging is a serious criminal offence and the college will make every efforts to PROHIBIT, PREVENT AND ELIMINATE the menace of ragging from all institutional spaces in its purview.**

**PUNISHMENT FOR RAGGING ACTIVITIES MAY RANGE FROM SUSPENSION, AND EXPULSION AND TO SEVERE LEGAL PENALTIES LIKE JAIL IMPRISONMENT .**

## **Preface:**

**Ragging** is a disturbing reality in the higher education institutes of our country. Despite several measures taken by the court, UGC and other concerned authorities over the years, it continues to persist in various forms. There are several instances where ragging has claimed innocent lives. To ensure a ragging free campus and endorse zero tolerance to ragging, Durgapur Government College has formulated an Anti-Ragging Policy based on the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009. It aims at promoting a safe and healthy academic ambience on and off campus. The policy document will serve as a guide to the stakeholders of the institution in their mission to ensure a ragging free campus.

## **Introduction:**

The College has framed a coherent and an effective anti-ragging policy based on the 'UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2009'. The UGC Regulations have been framed in view of the directions issued by the Honourable Supreme Court of India to prevent and prohibit ragging in all Indian Educational Institutions and Colleges. The Anti-Ragging Committee Policy touches upon the functionality, procedure, principles, scope, ways, implementation and means of upholding the objectives set by the cell, for the college.

## **Defining Ragging:**

Ragging constitutes one or more of the following acts:

- Any conduct by any student or students whether verbal or written or by an act which has the effect of teasing, verbal/physical rudeness, impolite and/or indecent gesture towards any student;
- Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship,

physical, psychological or emotional trauma/harm or to raise fear, anxiety or apprehension of danger thereof in any other student;

- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, torment or embarrassment so as to adversely affect the physique, psyche or emotions of such a student;
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any student;
- Exploiting the services of a student for completing the academic tasks assigned to an individual or a group of students;
- Any act of financial extortion or forceful expenditure burden imposed on a student by fellow students;
- Any act of physical abuse including all variants of it: sexual abuse, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- Any act or abuse by spoken words, emails, post, public insults, social media posts which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to any other student;
- Any act that affects the mental health and self-confidence of any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any other student

The cell and the squad will be the Supervisory and Advisory Committee for preserving a culture of Ragging Free Environment in the college campus. They will engage in the work of spreading awareness regarding ragging, keeping an eye on places of student congregation like Hostels, Canteens, Classrooms and taking necessary measures in case any such complaint or information is received.

The concerned bodies also ensure that the students sign the Anti-Ragging undertaking available in National Anti-Ragging website.

**Actions Suggested by AICTE/UGC against students indulging and abetting in Ragging (to be strictly followed by the institution):**

1. The punishment to be meted out to the persons indulging in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents. The students who are found to be indulged in ragging should be debarred from taking admission in any institution in India.
2. On every single incident of ragging, a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.
3. Depending upon the nature and gravity of the offence, as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:
  - a. Cancellation of admission
  - b. Suspension from attending classes
  - c. Withholding/withdrawing scholarship/fellowship and other benefits
  - d. Debarring from appearing in any test/examination or other evaluation process
  - e. Withholding results
  - f. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.

- g. Suspension/expulsion from the hostel
- h. Rustication from the institution

### **Redressal of Ragging Cases Reported**

- On receiving a report/complaint (orally or in written form), the committee and the squad members shall immediately arrange for securing the complainant and/or victim
- The victim should be taken for counselling
- A written complaint shall be received from the complainant and/or victim describing the full details instance, date, time and place of occurrence
- The complainant's and/or victim's identity such as name, class, semester, section, contact number, e-mail ID, parent's name, parent's contact details shall be obtained
- The alleged's identity such as name, class, semester, contact number, email ID, parent's name, parent's contact details, shall be obtained
- The complaint shall be noted down in the Ragging Complaints Book.
- A hearing shall be held in the presence of the Anti- Ragging Committee and Squad, to resolve the issue to decide upon the action
- The actions against the alleged if found guilty shall be recommended by the concerned bodies

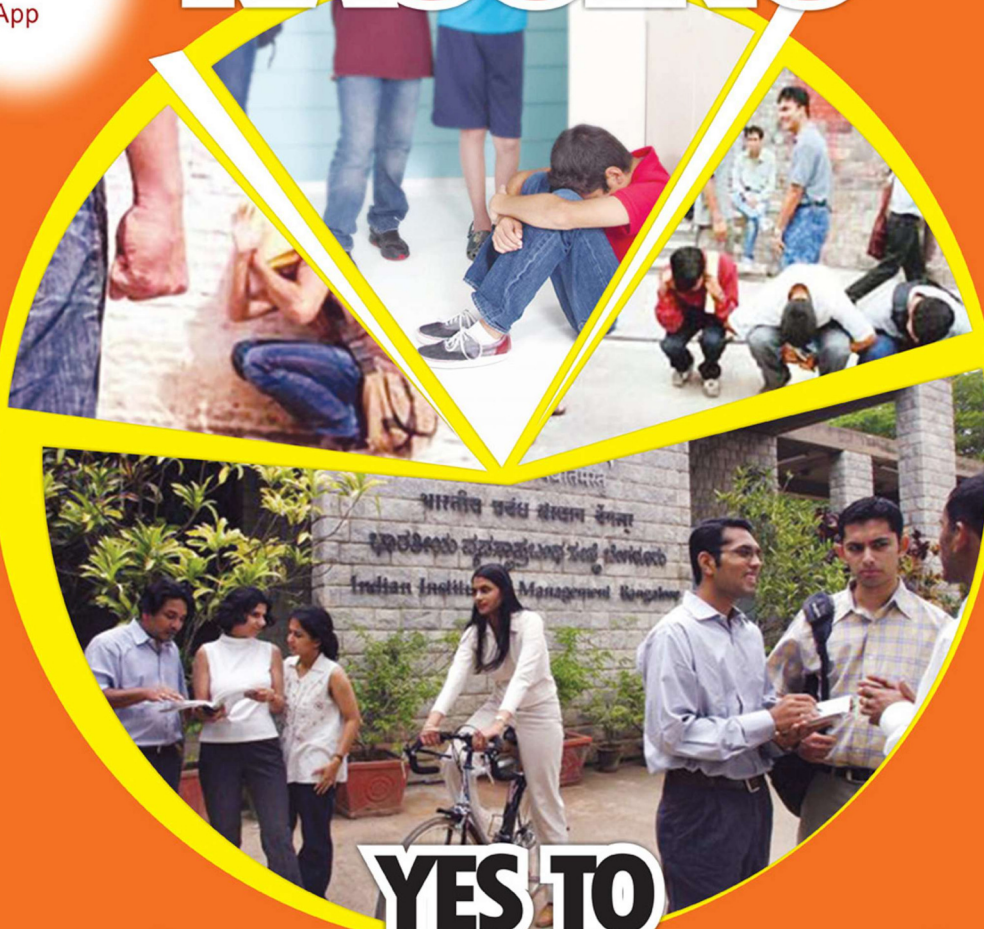

### A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

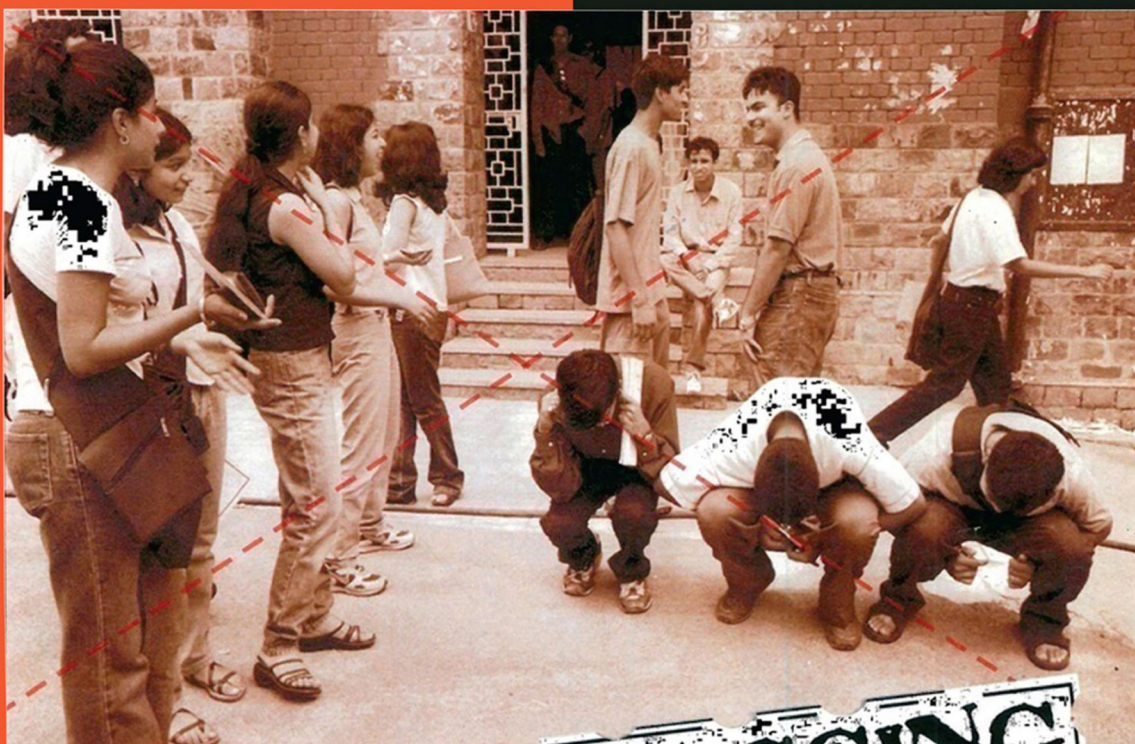
